1. Introduction

NMD Construction (Pty) Ltd respects your privacy and is committed to protecting your personal information in accordance with the **Protection of Personal Information Act 4 of 2013 ("POPIA")** and **Promotion of Access to Information Act 2 of 2000 ("PAIA")** together with other applicable South African legislation.

This Privacy Policy explains how we collect, store or process, use or share and protect personal information when you visit our website, communicate with us, request information, submit enquiries, or engage with our services.

By using this website, you acknowledge that you have read and understood this Privacy Policy.

2. Information we 'Collect'

We may collect the following personal information that we may deem necessary for legitimate business purposes as listed below:

- Name and surname;
- Contact details including telephone number and email address;
- Company details and position;
- Information submitted through enquiry forms;
- Tender, project, procurement or business-related information;
- Records of communication with us;

- Website usage information, including IP address, browser type and pages visited.

We will not collect, use or disclose sensitive information (such as information about racial or ethnic origins or political or religious beliefs, where relevant) except with your specific consent or in the circumstances permitted by law.

3. 'Purpose / Use' of Collecting Personal Information

We may use your personal information for purposes including:

4. 'Processing / Storing' of Personal Information

We will only process and store personal information where:

- Processing and storing are required by law;
- Processing and storing are necessary for legitimate business interests.

5. Sharing of Information

We may share information with:

- Professional advisors;
- Service providers assisting with business operations;
- Regulatory authorities where legally required.

We do not sell, rent or trade personal information to any third party.

6. Protection of Information

We implement reasonable technical and organisational safeguards to protect personal information against:

- Unauthorised access;
- Loss;
- Misuse;
- Alteration;
- Disclosure.

While we cannot ensure or warrant the security of any Personal Information you provide us, we can assure you that we will continue to maintain and improve these security measures over time in line with legal and technological developments.

7. Retention of Information

We retain personal information only for as long as it may be deemed necessary for:

- The purpose it was collected;
- Contractual obligations;
- Legal and regulatory requirements.

8. Your Rights Under POPIA

You have the right to:

- Request access to your personal information;
- Request correction or deletion of information;
- Object to certain processing;
- Withdraw consent where applicable;
- Lodge a complaint with the Information Regulator.
